## Notice for Election of Executive Committee Members of Indian Desalination Association (InDA) for the term 2017-19

### Election Notification

Nominations are invited for eleven posts of Executive Committee for the term April 2017- March 2019. Elections will be held, if necessary, as per the schedule indicated below:

Mailing of Election Notification to all members of InDA : Jan 9 to 11, 2017

Receipt of completed Nomination Forms : Jan 27, 2017

Scrutiny of Nomination Forms &  
Declaration of Eligible candidates. : Jan 30, 2017

Withdrawal of Nominations : Feb 10, 2017

Election procedure : Feb 11 to Mar 10, 2017

Counting of votes and declaration of results : March 16, 2017

### Who is eligible to file the Nomination Form/Proposer/Secunder

1. A person who has become a life member of InDA before 1st Nov 2016.
2. A person who represents a Corporate Member as on 1st Nov 2016.
3. A person who is an Annual member for last three years before 1st Nov 2016.

### Requirements of Nomination

1. Duly completed nomination form signed by nominee/ proposer/Secunder.
2. In case of corporate nominee, an authorization letter from the competent authority nominating the person concerned.
3. In case of corporate nominee, a declaration by the candidate that he would resign from the executive committee membership in case he ceases to be employee/a member of the corporate body.
4. A brief bio-data of the candidate specifically highlighting his contributions /potential to contribute the objectives of Indian Desalination association.
5. A declaration to the effect that the elected member would attend at least one third of the executive committee meetings in a year.


